

2011 NWD REVIEW: NWD V5.0, February 2012

AWEX Members and stakeholders are advised that the AWEX Board has approved recommendations in relation to the 2011 NWD Review conducted by ISAC (Industry Services Advisory Committee). As part of the annual review of the NWD, ISAC considered submissions from stakeholders from various stages of the wool pipeline.

A key focus of the review was to make the NWD more intuitive to increase uptake and minimise errors in completing it. The outcomes of the review are:

1. Brief definitions have been added to the Classer's Specification/NWD as a reminder to the Owner/Manager.
2. Definitions of Mulesed and Non-Mulesed (NM) have not changed.
3. Definitions of Ceased Mulesed (CM) and Pain Relief (PR) have not changed but have been reworded to improve clarity and interpretation.
4. There is no change to the property level question regarding Ceased Mulesed: answer "Yes" or "No" to the question "Has Mulesing Ceased on this property?"
5. There is a change to the mob level question about whether a mob is "NM" or "PR". The question now asks the Owner/Manager to identify, if applicable (otherwise leave blank), "NM" for a Non Mulesed mob or "PR" for a mob mulesed with Pain Relief. Previously this was two questions asking Yes/No for each mob.
6. To improve data entry issues, versions of the NWD that are specific to the data entry software used by the Seller have been produced, with both Landscape and Portrait versions available.
 - Where the software does not automatically calculate the Mulesing Status in **V5.0a**, a Mulesing Status column has been added to the central section of the Speci allowing wool technical staff to apply it at a lot level.
 - If the software automatically calculates the Mulesing Status, **V5.0b** is appropriate.
 - For Sellers who want to continue to use the separate NWD, the NWD V5.0, February 2012 version is also available.
7. The question related to "Keeping a record of Chemical Use" has been removed.
8. The Bin Code column has been moved to the right hand side of the Speci so it is next to the Classer's Comments and the Codes are not mixed up with the Bale Numbers.

The NWD continues to be combined with the Classer's Specification to reduce duplication, with a separate page detailing the Definitions, Background and Guidelines for completing the NWD.

MIDDLE SECTION – the “Mob Numbers” column is critical as it is the link between the NWD and the line of wool, so it should be wide enough to write down up to 4 mobs. AWEX will strongly encourage Woolclassers to list all mobs for each line of wool. This should simplify the calculation of Mulesing Status and DMFR.

While the shading may be removed if it causes a problem for faxing, the double lines are referred to in the Definitions, Background and Guidelines. *Note;* the other columns that are not highlighted (e.g. Length or VM) are at the Seller’s discretion and may be modified to suit your requirements.

NWD DEFINITIONS, BACKGROUND AND GUIDELINES – to ensure that all aspects of the NWD are understood, it is important that this page is supplied with every set of shearing stationery so that the wool grower understands the NWD and what they are signing. It may, for example, be printed on the front or back cover of the stationery or as a separate sheet.
