6.1 WEEKS 12/13/14 SELLING ARRANGEMENTS – PUBLIC HOLIDAYS

NASC reviewed a draft of the Selling Arrangements proposed for sale weeks 12, 13 and 14. Each of these weeks will be impacted by Public Holidays held during weeks 13 and 14.

The Representatives from Northern and Western regions confirmed arrangements for their respective Sales. Arrangements for Southern Region, particularly catalogue deadlines for M14 will be reviewed closer to the date, when indicative quantities are known (and the likely number of sale days are established).

6.2 SOUTHERN REGION DISPLAY SALE

The feasibility of holding a display sale (similar to the SRES/IWTO auctions) in Southern Region was discussed (as a promotional activity). The following points were noted:

- A suitable event and/or venue is required.
- There needs to be support from the hosting organisation.
- If not the host a (suitable) sponsor is required to cover the costs of hosting.
- A Service Provider is required.
- The logistics need to ensure the sale is run as close as possible to commercial conditions.

The Royal Show and Bendigo Sheep Show were mentioned. The latter was noted as often held during the Recess. It was suggested the RAS-VIC be approached to determine if there was interest.

6.3 GOULBURN – NORTHERN REGION

The Committee was given an update on the status of preliminary discussions exploring the option of Goulburn becoming the venue for Northern Region wool auctions.
