**N76/23/3.0 OTHER BUSINESS**

**3.1 WOOL SELLING PROGRAM**

**3.1.1 MID-YEAR RECESS**

Discussion on this topic continued from NASC75. Buyer Representatives believed there was increasing support from their sector for a move in the mid-Year Recess. This proposal was firmed to weeks 5-6-7, allowing four clear weeks of trading.

**ACTION(S)** Representatives to consult with constituents on July Recess.

**3.1.2 AUSTRALIAN SUPERFINE (AS) DESIGNATED SALES**

NASC considered correspondence from a buyer expressing concern about the AS Sales and the (limited) quantity of Saxon Style wool on offer. There are seven Sydney Sales designated as AS.

The committee agreed it was timely to survey the market on whether the AS Sales were meeting industry needs.

**ACTION(S)** Representatives to consult with constituents on AS Sales.  
Secretary to write to Australian Superfine Wool Growers Association.

**3.2 DELIVERY BOUNDARIES**

The Secretary advised the committee he was yet to write to brokers asking them to review their delivery boundaries to ensure they were current.

**ACTION(S)** Secretary to write to brokers.

**3.3 PROMPT DATE (LOCAL)**

The Secretary briefed the committee on a query raised about whether the broker prompt date should reflect a local Public Holiday when the broker business was based in another state.

The committee confirmed its view that the prompt date should reflect the Public Holiday conditions in the state of the auction.

**3.4 TERM EXPIRY**

The three-year term of the Northern Region Broker Representative (Andrew Mills) and the Fourth Buyer Representative (Brian Vagg) as due to expire.

The Chairman thanked Andrew and Brian for their contribution over the three years.
