## **N82B/24/2.0 RESALE LOTS WITHOUT A SAMPLE**

The Chair opened this topic with the following statement: "On reflection after the (NASC82) Meeting on the Buyer Reoffer without Sample topic, I realised the four Representatives supporting the proposal on a trial basis were from Southern Region.

I would therefore like the Committee to (re)consider the proposal on the basis that is held as trial in Melbourne for a period of 12 months."

The Chair asked the Representatives if there was any change in their position regarding their local regions. All Representatives reported an unchanged position.

The Chair then invited the Committee to consider whether they would support a trial in the Southern Region given that all Representatives with Southern Region constituents supported a trial.
