

Wool Classer Registration

In the period July to December 2023, AWEX registered 154 graduates as Wool Classers. As of September 2024, there are 15,057 registered Wool Classers in Australia.

The current registration period expires on 31 December 2024. Re-registration of wool classers for the 2025–27 triennium has commenced with email and SMS invitations released from 24th September.


We encourage paperless renewals by renewing online or over the phone. For those yet to renew by late October, paper forms will be printed and posted.

Updated Code of Practice (COP) for the preparation of Australian wool clips

The COP has been updated with feedback from industry and updates to definitions and guidance to further strengthen Australian Wool Classing.



Wool Classers will receive a copy of the updated **COP** in their re-registration packs upon successful renewal of registration.



Quality Matters: Contamination

Contamination from non-wool articles, in particular rubbish, twine, rope and clothing, continues to be a priority topic for wool customers.

Classers can assist by remaining vigilant to all contamination and by highlighting to all staff and Wool Growers that contamination prevention is a shared responsibility.

Strong growth continues for WoolClip

The uptake and acceptance of WoolClip continued in 2024.

Support from Brokers and Private Treaty Merchants was essential in this improved result. A strong driver of the interest in WoolClip is coming from growers and Classers wanting to improve data capture on farm, including the use of eBale.

As old wool packs are exhausted and eBales become more prevalent throughout Australia, it is expected that interest in WoolClip will grow further. AWEX will continue its extension program for WoolClip & eBale into 2025.

In 2023/24 a total of 262,222 bales were captured using WoolClip.

In the recent rolling 12-month period (Oct-Sep 2024) 275,565 bales were captured on WoolClip. +64.5% increase on 2022/23.

+41.6% increase on the same period in 2023.

These popular sessions allow users to gain confidence using WoolClip and to be able to see firsthand how to create a WoolClip specification and incorporate eBale technology.

Workshops are structured to meet the level of all participants, from those with a high level of technology skills to first time users.

NWD Integrity Program

Statistics

The NWD Integrity Program is valued by the supply chain as Exporters require certificates of verification from AWEX in support of purchases for their customers. AWEX receives NWD Mulesing Status verification requests on a weekly and daily basis.

With the first quarter of the 2024/25 selling season at a close, the national declaration rate sits at 76.8%. This figure will consolidate as the selling season progresses, with review of premiums and discounts for mulesing status affirming a discount of 10–12 cents/kg for Non Declared (ND) Merino wool.
